Terms and Conditions

1. The Applicant warrants and represents to the Management that the enclosed information is true and correct. This application will not be acted upon unless fully completed, signed and accompanied by a payment for the required fees. The applicant understands that membership in the Club and any privileges to use the club facilities shall terminate as defined herein, and that the fees and charges applicable to membership are subject to change from time to time.
2. The applicant acknowledges and agrees to be bound by the terms and conditions thereof, as amended from time to time, in the sole discretion of the Club. Membership privileges may be terminated for failure to abide by any Membership conditions.
3. The applicant acknowledges and agrees to be personally responsible for all charges and expenses as may be incurred by authorized family members and guests. Membership privileges may be suspended if applicant's account balance becomes over 30 days delinquent.
4. The Applicant hereby acknowledges that membership in the Club is not an investment in the Club, nor does it provide an equity or ownership interest in the Club or the Club facilities. The Club reserves the right, in its sole and absolute discretion, to restrict or otherwise reserve the Club facilities for maintenance, tournament play and other special events from time to time. The payment of monthly dues or daily golf fee is required to acquire and maintain membership privileges. With exception of these dues, members are not subject to any liability or assessment for the cost and expenses of ownership or management of the Club or the Club facilities.
5. The applicant further acknowledges that the use of the Club facilities and any privileges or service incidental to membership in the Club is voluntary and that any use or acceptance of any service or privilege incidental to membership is undertaken with knowledge of the risk of

possible injury. In accepting this risk of injury, the applicant understands that he or she is relieving the Club and those employed by or affiliated with the Club from any and all loss, cost, claims, injury, damage, or liability sustained or incurred by the member, member's guest and family members resulting from or arising out of any conduct or event connected with the membership in the Club and use of any of the Club facilities.

6. The applicant acknowledges that the membership fee is the property of the Club, and neither that membership or the membership fee is transferrable or assignable.
7. An initiation fee of \$1,500 will be due upon receipt of application, unless other arrangements are made, along with the first month's dues and all applicants must sign a minimum 12-month contract. However, applicants that are first time members since January 1st, 2013 and sign a 24-month or 36-month contract will have their initiation fee reduced. The initiation fee for a 24-month contract will be \$750 and the initiation fee for a 36-month contract will be waived. Account balances that are not paid by the 25th of the billing month will incur a \$20 late fee.
8. The applicant understands and agrees that the term of this membership shall be for 12, 24, or 36 months beginning upon the signing of this agreement, and the applicant agrees to pay all membership fees for the type of membership selected for the 12, 24, or 36 months.
9. All membership accounts must be set up on recurring monthly ACH drafts for the full balance of their account as of each month end. ACH drafts will occur on the 10th of each month or nearest work day thereafter.
10. Members must use their charge accounts for any and all purchases in the restaurant, pool, and pro shop. Credit cards and cash will not be accepted.
11. Membership Qualifications:
 - a. Family – Married couples or individuals with minor children who want to have full club privileges including golf, pool, restaurant and bar. Membership applies to all unmarried children under the age of 18 or those attending secondary education full time under the age of 25 who live at home.
 - b. Individual – Single man or woman who want to full club privileges including golf, pool, restaurant and bar.
 - c. Junior – Married couples or individuals under the age of 35 who want full club privileges including golf, pool, restaurant and bar. Membership applies to all

unmarried children under the age of 18 or those attending secondary education full time under the age of 25 who live at home.

- d. Out of County – Married couples or individuals who want full club privileges including golf, pool, restaurant and bar but who live outside of Independence County. Membership applies to all unmarried children under the age of 18 or those attending secondary education full time under the age of 25 who live at home.
- e. Social Deluxe – Married couples or individuals who only want pool, restaurant and bar privileges. Membership applies to all unmarried children under the age of 18 or those attending secondary education full time under the age of 25 who live at home.
